B; I INDEMNIFY, HOLD HARMLESS AND PROMISE NOT TO SUE the entities or persons mentioned on this Waiver and Release of Liability form from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise.

I understand that this event or activity may involve animal interaction with other people and may carry with it the potential for death, serious injury and property loss.
